


Why are we making this change?

• New regulations from Department of State allow authenticated digital signatures to be applied to DS-2019 forms and for sponsors to disseminate those forms by electronic means.



How did we make decisions?

- Extensive meetings with CIEE program groups & IR focus groups
- Multiple surveys to IRs
- Data-driven decisions essential vs. nice-to-have & impact to user

International Rep Control

IRs "control" participant access to the DS-2019 form



Printed forms for Pax

Pax need printed form and SEVIS fee receipt to apply for a visa



ARFs

Some ARFs will continue to be processed by manual changes in SEVIS (exception = DS date changes)





Beacon Grid

"Manage DS-2019 Forms" is used as IR tool to "Release" forms (CIEE Staff have access to the grid)

Beacon Pax Page

Used to download DS-2019 form (Pax, CIEE Staff, and IRs view this page, only Pax and CIEE Staff can download)

No print & ship!

Pax Services no longer print, sign, and ship initial DS-2019 forms

What are the core features?

- The e-signature applied in CIEE's VIPER system
- Form release in Beacon (CIEE Staff & IRs)
- Form downloads in Beacon (Pax)
- Form access in Beacon (Pax, unavailable to IRs)
 - Available: SEVIS Initial Status
 - Not Available: Shortened, Inactive, Canceled, Active Status
- Changes to the form:
 - If first form is released using new system: updated forms with DS Date changes will also be available in new system & pax will receive email
 - If first form is released before new system: amended forms will not be currently available in new system.
 - Other changes (SOA, biographical, etc.) = manual updates in SEVIS, not available in new system.




Participant Experience

- Receive email when IR releases the form
- Customized landing screen & button on Application page to access form
- Access "Initial" form & forms with updated DS dates
- Pax forms page:
 - Acknowledgements that serve as instructions
 - Customized by IR name for easy follow-up
 - Form access while in SEVIS Initial Status
 - NO form access while in SEVIS Canceled, Shortened, or Inactive Statuses
 - Future "Reprint" for pax in SEVIS Active status



International Representative Experience

- Can opt in to manual or automatic release by LOA and product
- Manage DS-2019 Forms Grid
 - Can release form & resend email to pax records by multi & singleselect
 - Can change columns, including fields required on the I-901 Form
 - Can export CSV
 - Can filter with "All" features
- DS-2019 Form Button & Pax Page
 - Can view page
 - Cannot download form (due to DoS regulations)

- Prefer Auto-Release of DS-2019 forms?
 - Everyone will default to manual release
 - Contact International Ops to change your settings
- ARFs (Action Request Forms)
 - International Ops will send communication with any process changes, if applicable
- Are there some DS-2019 forms that will still need to ship via FedEx?
 - International Ops will send out information on which cases (ex: reprint of a DS-2019 that was originally shipped)
- ✓ What if a pax loses their DS-2019 while on program?
 - → Call CIEE to request a new one (1-888-268-6245)
